# Consent agenda was moved and passed including the following:

## Worship Committee, Judy Ives and Jan Lafayette, chairs:

- We celebrated Easter on April 21.
- A special Earth Day worship service was held on April 28. Despite the technical difficulties, we had
  very positive feedback. We will be showing the photo videos which we couldn't show that day during
  worship services in the near future.
- We worshipped in Bainbridge with the Presbyterian Church during Patty's absence on May 5. Terri Barnhart preached, and communion was served by Cheryl Nages.
- Rev. Dr. Barbara Renton preached at our church on May 12, which was also during Patty's vacation.
- Judy Ives organized her annual afternoon of inspirational music. It was held on May 19 and was wellattended.

#### **Building and Grounds, Dave Williams, chair:**

- Gordon is mowing the lawn but will be away July through August. I have ordered a trailer so I can move my
  mower so Gerry Harris and I will be on duty for the times Gordon is away.
- There are numerous issues with the building that need attention. We have few able bodied men and will set up a special meeting to include Tim DuMond and Jim Johnson for the purpose of identifying and prioritizing the work to be done. Hopefully we can recruit volunteers at the same time.
- I repaired the water line that feeds the coffee pot which appears to have been sliced.
- We need to remind each other to leave doors closed between the various sections of the building. I've been
  finding doors open while we are trying to heat just one space. This wastes fuel and makes it difficult to bring
  the desired space up to the set temperature. Furthermore, closed doors are effective in slowing the spread of
  fire should one start.
- A report was received with information from the Building and Grounds inspection team's discussions on June 4th. People stepped up to be coordinators for various tasks that need to be completed: the sanctuary basement hatchway wall and cellar; painting of the decks and stairs; repair of window above door to narthex; painting Sunday School windows; rear hatch painting, washing the siding; installing light pole; church sign maintenance; and water shutoff valve on water main line.
- The toilet seat and sink in the narthex restroom have been repaired.
